The objects of the Trust are:

1. To open, run and maintain a School, College, Educational Institute, Religious Place, Vocational Institution, M.B.A college, Dental College, Hospital, Clinic, Nursing Home, Medical College or Health Resort for the general benefit of the public on Charitable basis.
2. To Purchase, procure, acquire or lease any Land & Building for the above object and to make constructions thereon.
3. The trust is entitled to enter into a public -Private partnership or a Joint Venture with Government, Semi Government or person includes firm to achieve the objects of the trust.
4. To acquire equipments, materials, instruments or other necessary paraphernalia on lease/purchase for the establishment of a School, College, Educational Institute, Religious Place, Vocational Institution, M.B.A college, Dental College, Hospital, Clinic, Nursing Home, Medical College or Health Resort.
5. To engage Teachers, Principle, Professors, Readers, Instructors, Administrative Officers, Lecturers, Director, Physicians, Surgeons, Nurses, Experts and all other employees and servants of good moral character who





8. To do all other things and carry out all other functions and incurs all expenses for the above objects.
9. To develop a healthy as well as critical attitude towards the development of mental, physical and moral uplift of the students and those connected with the institution so as to make them good citizens.
10. To purchase and accept mortgage Loan or Finance from Govt. Semi-Govt. or Private Body for and sell properties for the furtherance of the above objects.
11. To accept donation, grants, presents, offering medicines, instruments and all other equipment and to deal with the same for the purpose and objects of the trust.
12. To charge tuition fee and otherwise recoup themselves for the outlay and expenses incurred in the upkeep and maintenance of institutions established or about to be established under this deed.
13. To invest and deposit for the transfer and otherwise deal with other matter of the trust in such a manner as the trustees deem fit so as to enable the trust to carry of its objects effectively.
14. To train and equip the pupil so as to be self-supporting in an honourable and decent way of life so as to develop into good, healthy and progressive citizens.
15. To open training centres for students, nurses and for the physicians in the School, College, Educational Institution, MBA College, Dental College, Religious Place, Hospital established by the trust.

16. To bring out, encourage and develop the incentive and research facilities of the pupils and teachers and to afford opportunity for research work in art, science and industrial.
17. To open centres for vaccination and taking over preventive measures for the general diseases and for publication and distribution of the literature for educating the masses regarding health and preventive measures.
18. To develop discretionary conduct and a habit to observe the rule of law and self-restraint.
19. To organize and form any society for management of the trust and trust properties to carry out the objects of the trust.
20. To accept/take/procure Loan for the achievement of object of trust from Bank Financial institution/private person on the property of found, for the benefit of trust or its objects.

Proper accounts shall be maintained for trust in respect of income and assets of the trust. The trustees may payout such stipends and scholarships and on such terms, if any, as they may be commensurate with income of the subject matter of trust.

The trustees shall manage the subject matter of the trust by majority of trustees by circulation resolve upon. If any vacancy arises in the Board of Trustees or on account of death, incapacity or persistent neglect of any trustees, the remaining trustees may opt any person preferably within the families of the present trustees.

Any question arising in the administration or the trust shall be decided by the majority of the trustees acting for the time being.

If the conduct of member and/or members are not found in the interest of the trust and/or institution the Trust shall be entitled to ample the members

Appointment of members of Management committee will be done by the Trust/Majority of the Trustee.

Further any clause, modification, alteration may be made by the approval of majority consent of Trustee.

All the amounts of the trust shall be deposited in a scheduled bank and all payments as far as possible shall be made by the trustees by the cheque provided, however trustees may resolve for making payments in cash and keeping the amount in cash with the Chairman or any other trustee of the Board of trust by a resolution.

The trustees shall be entitled to do each and everything to spend the money of the trust in any way they think fit in furtherance of the objects of the trust.

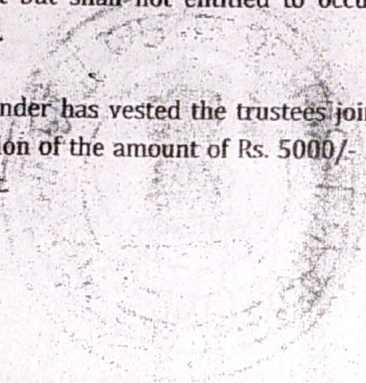
The trust is irrevocable.
